1. General Information

Can liners provided on this contract are a return to a mandatory thickness in response to user demand. The can liners awarded on this contract have been tested and evaluated to have significantly increased wet/dry load strength and capacity. This contract offers improvements to the can liners on prior contracts.

TO HELP YOU SELECT THE CAN LINER THAT YOU NEED WE OFFER THE FOLLOWING:

How do I choose the right plastic for the right application? Linear low-density bag verses a high-density bag?

Low-density bags are recommended for carrying sharper objects under tougher transport conditions. They are resistant to puncture and tearing.

High-density bags are great for paper and non-sharp objects under moderate transportation conditions. It uses less plastic than linear low-density bags. High-density bags have superior resistance to puncture and light resistance to tearing.

How do I know the strength of a bag?

The best way to determine the strength of a bag is to use the load rating value in the item tables (pages 3-5). Consider this load to be the lifting strength.

How do I choose the right bag for the right application?

Determine the type of trash that is being stored or hauled (paper, office trash, sharp objects and liquid containment). Select high or low density plastic in the item tables on pages 3-5. (Type1 Style1 or Style 2, or Type2). Determine the strength requirements and select the category of bag, light, medium, heavy duty. Determine the size of container and select the appropriate size bag from the item table.

The referenced webpage is provided as a general reference guide only . Some can liners referenced from the contract may be oversized to assure proper fit of minimum can opening or height. Some trash cans may also employ various sizes of rigid inner liners which may be different than the original can or rigid liners originally provided. If you already know the acceptable size liner needed, then use that size.

How do I know that the supplier has delivered the correct count of bags per case?

The way to verify that the correct quantity of bags being delivered is to weigh the unopened case. If the minimum case weight is less than the value shown in the item tables (pages 3-5) the order should be rejected.

Discounts for bulk purchases of can liners are offered on this contract (1-99 Cases, 100-499 Cases, 500-999 Cases and 1000-1500 Cases for each line item. Prices are listed on the e-procurement site. Biohazard bags can be purchased under your delegation.

2. Scope of Contract

The scope of this contract is limited to plastic can liners (types listed below) for use by all State agencies, departments, institutions, universities, community colleges, public schools (except those exempt by Statute) and certain Non-State agencies.

Type 1 Style 1	Linear Low Density and Low Density Can Liners (Light, Medium and Heavy Duty)
Type 1 Style 2	High Density Can Liners (Light, Medium and Heavy Duty)
Type 2	Linear Low Density and Low Density Can Liners (Heavy Duty)

3. Taxes

Prices or Discounts shown herein do not include any North Carolina sales or use taxes.

4. Abnormal Quantities

Any agency requirement that exceeds \$20,000 must be forwarded to the Division of Purchase and Contract for processing. The Division, at its sole discretion, may process any such requirement in one of the following ways:

- a. Purchase may be authorized at the current level of pricing with the current contract vendor(s)
- b. Additional discounts from the current level of pricing may be negotiated with the current contract vendor(s)
- c. A separate Invitation for Bids may be issued for the requirement

5. Minimum Orders

This contract will be for a minimum order of **\$150.00** for any single order. Agencies are authorized to purchase from best available sources on orders less than this minimum order value. This provision shall not be used by an agency to circumvent the intent of the contract. If an agency elects to place an order for less than the minimum order value, then transportation charges will be prepaid and added to the invoice.

6. Placement of Orders

Orders will be placed throughout the contract period on an as-needed basis for the quantity required at the time, and will be issued directly to the respective contractor(s) or their designated suppliers. Contract changes, if any, over the life of the contract are implemented by contract addenda released by the Contract Administrator to the contractor. If the contractor is accepting orders and/or delivering through other parties, for example a manufacturer accepting orders and delivering through a dealer network or dealers receiving orders through a network of other dealers, then it is the responsibility of the contractor to apprise such parties of all such contract addenda.


Order Placement Via E-Procurement (Catalog Items)

- When placing an order in the e-procurement system, the very first thing to do is to go to the catalog tab and select options. After you have selected options, select contract ID. In the contract ID space type in the contract ID number, 665B.

7. Delivery

Bidder agrees to make delivery within fourteen (14) days after receipt of order. In the event the delivery is not received within the contract delivery period, the contractor may be held in default in accordance with paragraph 1, Default And Performance Bond, in the North Carolina General Contract Terms and Conditions, and the State may procure the articles or services from other sources and hold the contractor responsible for excess cost occasioned thereby.

8. Transportation Charges

All goods shall be delivered FOB destination when the “order value” is **\$150.00** or more, when shipped to a single destination. Orders to a single destination that total less than this “order value” should be shipped prepaid, with transportation charges added to the invoice as a separate item. Transportation charges invoiced for orders equal to or more than this “order value” may be cause for removal of the contractor from the contract.

Note: If the contractor makes partial shipments of an order equal to or more than this “order value” to one destination, all shipments of the order shall be sent FOB destination with NO additional transportation charges added.

All shipments should be inspected for damage immediately upon receipt.
