Mandatory Contract	This is a mandatory statewide term contract for state agencies, departments, institutions, universities, and community colleges, unless exempted by North Carolina general statute. Non-mandatory entities, including schools and local governments, may use this contract as allowed by general statute.
Minimum Order	The minimum order amount to qualify for free shipping is \$500.00 for a single order. The state will be required to use this contract for orders less than the minimum order amount. However, in such cases, the order may be shipped prepaid and actual transportation charges may be added to the invoice as a separate line item. Additionally, products are available for local pickup from Green Resource at its Charlotte, Colfax, Garner, and Supply locations.
Delivery Information	Delivery shall be Free-On-Board (FOB) destination to any requested location within the State of North Carolina with all transportation costs and fees included in the total bid price.
Packaging and Storage	All items ordered shall adhere to the following packaging and storage requirements:
