SUBJECT: ADDENDUM NO. 1 – POKEBERRY CREEK CROSSING BRIDGE

This addendum is issued to provide answers to questions submitted by the deadline.

1. What is the estimated span length and width of the bridge?
A. *At a minimum, 65 ft. Length will be determined during the design process as impact areas are identified through survey and delineation and the workable area can be defined.*
2. Is topographic survey part of the submission? Is topographic survey available at this point?
A. *Topographic survey is not available and I don't believe it will be necessary for this project.*
3. We would sub the No-Rise certification. We want to verify this. –
A. *It is anticipated that no-rise will be required per our staff in the environmental quality division.*
4. Does the proposal require us to provide or sub-contract the geotechnical engineering borings and report?
A. *At this time I don't anticipate the need for any geotech or borings.*
5. Page 3 says "Architects must submit four (4) written bound responses and one electronic copy by 5:00 pm EST on Tuesday, January 8, 2019." Is the County specifically looking for an architect to prime this? Or an engineer?
A. *Engineer*
6. What is the county's budget for the project?
A. *\$100K in federal grant funds and \$25K in County matching funds.*
7. Would the county be interested in a prefabricated suspension bridge?
A. *The County would consider a prefab suspension, but it is my belief that the site logistics and accessibility will prohibit that type.*
8. Would the county be interested in a bridge that not designed as a suspension bridge, but looks like one aesthetically?
A. *The County is open to alternative design ideas.*
9. Can the submittal be printed double sided? If so, is the page limit 10 pages (5 pages double sided) or 20 pages (10 pages double sided)?
A. *10 pages total (5 pages double sided).*
