1. CALL TO ORDER AND ETHICS STATEMENT

Chairman John Kirkland called the meeting to order at 10:00 a.m. and read the Ethics Statement. There were no recusals.

10. SUBCOMMITTEES

Subcommittee on Legislative Study Commission Recommendations

Subcommittee Chair Steve Criscenzo reported that the subcommittee met after the last Commission meeting on July 22, 2008. The subcommittee sorted the recommendations of the Study Commission into five areas as follows:

- 1. Designer Evaluations (Lou Jurkowski)
- 2. Contract Schedules
- 3. Innovation (Paul Boney)
- 4. Quarterly Stakeholders
- Code Consistency (Susan Gentry)

Lou Jurkowski reported on the Designer Evaluations Group. She informed members that the electronic evaluations were currently being tested at NCSU and a report on the trial would be presented at the Commission's October meeting. Ms. Jurkowski reported that there currently are three databases used by DOI, SCO, and the University system and there is a lot of information available electronically. DOI is going to electronic approvals this week and within the next couple of months, the ability will exist to check electronically to determine the status of a project in the review process. DOI has also agreed to interface with InterScope (SCO's database).

Ms. Jurkowski reported that the Energy bill (SB668) will alter design contracts effective October 1 as well as the State Construction Manual. The Department of Administration-Energy Office is sponsoring a mini state conference on October 29-30 (Durham Marriott) to discuss the many contract changes due to this bill. Ms. Jurkowski stated that her group is waiting for comments from AIA and ACEC on the contracts before finalizing their recommendations and submitting them to Greg Driver, who will then send all

recommendations to the Attorney General's Office for review. Ms. Jurkowski said they anticipated having recommendations by the end of the year, but the actual contract revisions would not occur within that timeframe.

Susan Gentry had no report on the Code Consistency Group.

Mr. Criscenzo reported that the Subcommittee proposed that a Innovations and Cost Construction Group be formed and recommended that Paul Boney chair this group. Mr. Boney reported that the purpose of this group would be to act as a think-tank for innovative ideas and also serve as a resource for the Legislature and the State Building Commission. He presented the names of potential group members and welcomed any others to join them. Mr. Boney reported that the group would be meeting in September and report to the Commission in October. He passed out a handout listing preliminary thoughts and ideas for the group. Lou Jurkowski asked if there would be minutes of this group's meetings. Mr. Boney responded that he would prepare minutes and distribute them to everyone.

Chairman Kirkland asked if there was a motion. Sam Driscoll made a motion to form this group and the motion was seconded by John Thompson. The motion to form the Innovations Group passed.
