

# **Informal Contract**

- Per section 202.2 (c) of SCO Manual (or secton 102.5 new manual), an owner could request exemption from SCO plan review & oversight under the following conditions:
  - Project total cost under \$300K.
  - A written application requesting exemption & to include description of work, cost estimates and name of licensed designer (if any).
  - The plans, if any, are to comply with GS 133-1.1 a & b.
  - This Exemption is not applicable to SCO code review unless the project has limited scope of work, it involves no life safety modifications and there are no structural elements (i.e. painting, carpet replacement, lamp replacement and other maintenance type work).

# **Shop Drawing Reviews**

# Unless specified during the review process submit only the following if applicable:

## Sprinkler System:

✓ Drawings; Hydraulic calcs; cat. cuts; engineer's review.

## Structural:

- ✓ Pre-engineered Wood Roof Trusses.
- ✓ Pre-engineered Metal Buildings.
- Precast Building Structures (w/ primary structural design by precaster).
- Precast Parking Decks (w/ primary structural design by precaster).
- Light Gage Metal Framing (LGMF) for Bearing Walls (w/primary structural design by vendor).
- Permanent Pre-engineered Steel/Aluminum Bleachers.
- Other Systems (judiciously required when warranted on a project-specific basis).

Note: Fire alarm shop drawings are to be reviewed by the engineer of record only.

# Change Orders Reviews

- Contact the Project Monitor before submitting any CO Proposals for review.
- Designer of record is responsible for verifying compliance with all project terms and conditions.
- Plans are to be submitted for review on:
  - Any Life Safety Change
  - Changes affecting NCBC or other codes (i.e. NFPA)
  - Added scope of work
  - Reduction in scope of work




## Monthly Distribution of submittals for the last three years




## Monthly Distribution of all submittal phases for 2008

# **Key Notes**

- Always use the State ID Number when communicating with our office (9 digits # followed by a letter).
- Always include a transmittal letter with a brief description of package. If it's a code only, state "code review only".
- If approval w/ comments has been issued, no resubmittal is required for review except the responses to comments and a bid set.
- An approval, when issued from our office, is only good for six months; NC Administrative Code sec 204.3.2.
- AV, Theater Lighting & Kitchen systems are strongly recommended to be part of the project due to field coordination issues.

# Key notes (continue)

- Final stand up review can be requested if:
  - > The number of CD comments are not excessive.
  - Allow at least one week after we've received the final package for scheduling the review date.
- When designing geothermal wells verify with the local authorities for any conflict with their potable water aquifer.
- Any information submitted to our office will become public domain.
- Did I mention always provide the State ID number when communicating with our office?


# Top Ten Most Frequent Comments

- 10. Avoid extensive modification to the project General Conditions.
- Provide a list of all chemicals and potentially Hazardous materials stored and/or used (submit at DD).
- 8. Flood Plain Permit must be addressed early (SD or earlier).
- 7. Designer's seal must not be obscured for verification.
- Bids are to be received and opened at the same public location; designer's office is not a public location.

# Top Ten (continued)

- 5. Location of the service XMFR in relative to the building per ANSI/IEEE 979, 30 feet.
- 4. The AHJ on all State funded projects is the State Construction Office.
- 3. Missing/incomplete overall Life Safety Plan.
- Missing/incomplete Building Code Summary Sheet.
- The use of Sprinkler flexible piping is limited to braided SST type, corrugated flex is not be acceptable.
