North Carolina Small Business Enterprise Program (NCSBE) Launch

Established under [Executive Order No. 143](#), the North Carolina Small Business Enterprise (NCSBE) Program successfully launched August 2021. The Program was developed to provide access to contract opportunities that allow small and disenfranchised businesses to compete against others that are comparably positioned in their industries and markets as well as participate in department contracts if they meet the eligibility standards. The overall goals of the NCSBE program are to facilitate competition, eliminate obstacles, and increase opportunities for small businesses.

“The NCSBE Program is administered in partnership with the Office of Historically Underutilized Businesses to assist HUB and NCSBE certified businesses in North Carolina,” said NCSBE Manager Iris Reese. “In my role, with the support of NCSBE certification specialist, we will proactively endeavor to support small business enterprises that were disproportionately impacted by the pandemic.”

Director Hall Receives Diverse Supplier Advocate Award



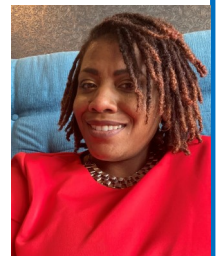
