SCOPE

This Qualified Products List identifies products that have been evaluated and approved as meeting the requirements of the current issue of North Carolina Specification 9390-1. It is not intended to include all types of commercially available retro reflective sheeting, but only the types covered in North Carolina Specification 9390-1 where two or more brands have been evaluated and approved.

I. GENERAL

This Qualified Products List is intended for use by the State of North Carolina in the procurement of retro reflective sheeting for license plates.

<u>Manufacturer's changes in specifications</u>: Any changes in specifications of the listed items shall be reported to this office in writing within five (5) working days after the change is implemented. The acceptability or lack thereof of the revised product will be made at the sole determination of the State. Failure to properly report changes in specifications in accordance with the above may result in removal of the item from this list.

Manufacturer's change in product identifier only: Any change in the product identifier of a listed item, where no change in manufacturer's specifications has occurred, shall be reported to this office in writing within five (5) working days after the change is implemented. The State reserves the right to investigate the circumstances and to subsequently accept or reject the reindentified product, whichever the State in its sole judgment deems appropriate. Failure of bidder to properly report changes in product identification in accordance with the above may result in removal of the item from this list.

<u>Discrepancies in product identifiers</u>: In instances where the manufacturer's product identifier and the identifier listed in the QPL differ, the State reserves the right to investigate the circumstances and to subsequently accept or reject the product in question, whichever the State in its sole judgment deems appropriate.
