- 3. A delivery ticket shall accompany each delivery. Volume delivered and invoiced will be based on net gallons.
- 4. Allocation deliveries are not accepted.

Conversion, (Agency to Vendor)

Delivery, and or installation will be completed within eight (8) to 10 weeks after the Vendor receives the purchase order.

Conversion, (Vendor Pick-Up)

Pricing includes transportation from the agency to the Vendor's site and back. The conversion will be completed within eight (8) to 10 weeks after the Vendor receives the purchase order.

Fuel Dispensing System

The Vendor will complete the delivery, and or installation within 10 to 12 weeks after the Vendor receives the purchase order.
