EXECUTIVE SUMMARY

When examining FY 2009-2010 (July 1, 2009-June 30, 2010) HUB participation by category, significant participation variations are observed, including:

•	Purchasing (Goods and Services):	6.54 %	(\$292,210,342 of \$4,466,041,356)*
•	Construction Projects:	18.49%	(\$143,619,332 of \$776,545,058)*

While the amount of funds spent on **HUB Purchasing** (Goods and Services) between FY 2005-2006 and FY 2009-2010 has varied from a low of \$338.5 million to a high of \$442.6 million, the percentage of HUB participation in total state purchasing has remained fairly steady during the same period, ranging from 6.54% to 8.1%. For FY 2009-2010 HUB participation reported by the reporting entities is 6.54%. The State's goal remains at 10%.

Significant variations also are seen in HUB participation for various HUB categories:

STATEWIDE UNIFORM CERTIFICATION (SWUC) PLAN

During FY 2009-2010, considerable staff effort was focused on developing Statewide Uniform Certification standards and procedures for July 1, 2009 implementation date. Statewide Uniform Certification was designed to streamline the certification process, reduce the redundancy in certifying minority and women owned businesses and create a centralized HUB and minority/women business database. The HUB Office will take the lead in certifying HUB and Minority/Women Business Enterprise (M/WBE) firms that previously had to apply for certification both through the state HUB Office and local M/WBE program offices.

Statewide Uniform Certification is the result of <u>N.C. General Statute 143-128.4, 143-48.4.</u> It was developed by the HUB Office in collaboration with local M/WBE program directors and with feedback from HUB firms, prime contractors and HUB resource advocates. In addition to increasing efficiency and service to the HUB community, Statewide Uniform Certification establishes a centralized database for state agencies, local municipalities and contractors looking to identify and utilize HUB vendors and sub-contractors.

DOA's Management Information Systems developed the online system used to certify potential HUB firms.

Community Colleges reported 94.8% conclusively for all four quarters. At year-end, Community Colleges reported 7.18% HUB participation, with a total of \$389,441,324 in purchases and \$27,966,786 reported HUB participation.

Public Schools Districts reported 73% conclusively for all four quarters. At year-end, Public School Districts reported 8.52% HUB participation. The Districts reported total purchases of \$1,724,867,211, with \$147,021,415 reported in HUB participation.

State Universities reported 89.5% conclusively for all four quarters. At year-end, Universities reported 4.36% HUB participation. The Universities reported a total of \$1,115,848,571, in purchases with \$48,632,470 reported in HUB participation.

ENTITIES THAT MET OR EXCEEDED THE STATE'S 10% GOAL FOR FY 2009-2010 INCLUDE:

Three of 10, or **30% of Cabinet Agencies** met or exceeded the State's goal, with the **Department of Cultural Resources** at 12.19%; the **Department of Revenue** at 10.58% and the **Department of Health and Human Services** at 10.43%.

Five of nine, or **55.6% of Council of State Agencies** met or exceeded the State's goal, with the **Office of the Lieutenant Governor** at 73.6%; the **Office of the Secretary of State** at 24.49%; the **Department of Labor** at 18.89%; the **Office of the State Auditor** at 15.71% and the **Department of Public Instruction** at 11.80%.

Six of 13, or 46.2% of Supporting Agencies met or exceeded the State's goal, with the N.C. Institute of Minority Economic Development at 77.44%; the Office of Administrative Hearings at 29.08%, the N.C. Education Lottery at 21.85%, Employment Security Commission at 15.77%, Rural Economic Development at 14%; and the Wildlife Resources Commission at 13.6%.

Thirteen of 58, or 22.4% of Community Colleges, met or exceeded the State's goal.

Fifty-two of 115, or **45.2% of Public School Districts**, met or exceeded the State's goal.

Four of 19, or **21.1% of the State Universities**, met or exceeded the State's goal, with the **N.C. School of Science and Mathematics** at 45.33%; **UNC- Greensboro** at 13.33%, **East Carolina** at 12.78%; and **N.C. A&T State** at 11.97%.

Supporting Agencies reported 99.42% HUB participation. The Agencies reported a total of \$8,237,540 in construction, with \$8,189,402 reported HUB participation.

Community Colleges reported 8.03% HUB participation. The Colleges reported a total of \$60,226,330 in construction, with \$4,833,779 reported HUB participation.

Public School Districts reported 15.08% HUB participation. The Districts reported a total of \$411,642,840 in construction, with \$62,080,835 reported HUB participation.

State Universities reported 30.97% HUB participation. The Universities reported a total of \$165,691,186 in construction, with \$51,321,942 reported HUB participation.

Counties reported 10.45% HUB participation. The Counties reported a total of \$54,526,969 in construction, with \$5,700,199 reported HUB participation.

Municipalities reported 13.91% HUB participation. The Municipalities reported a total of \$60,493,875 in construction, with \$8,413,848 reported HUB participation.

- Eight of 59, or 14%, of <u>Community Colleges</u> registered to HUBSCO met or exceeded the State's goal.
- Ten of 67, or 15%, of <u>Public School Districts</u> registered to HUBSCO met or exceeded the State's goal.
- Eleven of 21, or **52%**, of <u>Universities</u> registered to HUBSCO met or exceeded the State's goal.
- Three of 53, or **6%**, of <u>Counties</u> registered to HUBSCO met or exceeded the State's goal.
- Nine of 93, or **10%**, of **Municipalities** registered to HUBSCO met or exceeded the State's goal.
- None of 7, or 0% of <u>Hospital Associations</u> registered to HUBSCO met or exceeded the State's goal.
- None of 13, or 0% of <u>Public Housing Authorities</u> registered to HUBSCO met or exceeded the State's goal.
- None of 5, or 0% of <u>Water and Sewer Authorities</u> registered to HUBSCO met or exceeded the State's goal.
- None of 2, or 0% of <u>Non-State Agencies</u> registered to HUBSCO met or exceeded the State's goal.
- None of 4, or 0% of <u>Airport Authorities</u> registered to HUBSCO met or exceeded the State's goal.

IN CONCLUSION, FY 2009-2010 records 46 of the State's 340 reporting entitles (13.5%) meeting or exceeding the State's 10% goal. The State's overall HUB Construction participation rate is 18.49%.

The HUB Office reminds all reporting entities of the need to make continued efforts to increase the total amount of construction projects acquired from HUB vendors.



HIGHLIGHTS OF SIGNIFICANT ACTIVITIES FOR HUB OFFICE

- The HUB office staff focused considerable effort and worked with internal and external partners to prepare for the July 1, 2009, launch of the <u>Statewide Uniform Certification</u> (SWUC) Program (G.S. 143-128.4 and 143-48.4). In addition to building consensus among entities that formerly issued certifications, HUB developed training modules with Management Information Systems for its new certification system, as well as presented three live, statewide broadcasts on different aspects of the SWUC Plan via the Agency for Public Telecommunications.
- The HUB office staff responded to approximately 10,984 telephone and email inquiries from HUB vendors/contractors, state agencies, other entities and the general public; providing assistance and/or information on the State's HUB Program, HUB Certification, E-Procurement, HUBSCO, Purchasing and Construction Opportunities, HUB/Minority Business Construction Reporting Requirements (G.S. 143-128.2, 143-128.3, and 143.131) and G.S. 143-48 HUB/MWBE – Minority Business Purchasing Reporting Requirements.
- Participated in 41 conferences, workshops, seminars, training session or presentations for the purpose of promoting the HUB Office, HUB Certification Vendor Link, E-Procurement, Minority Business Construction Reporting Requirements (G.S. 143-128.2, 143-128.3, and 143.131) and G.S. 143-48 HUB/MWBE – Minority Business Purchasing Reporting Requirements.
- Certified 1,889 businesses as HUB vendors and/or contractors.
- From the inception of the HUBSCO Construction Reporting System beginning March 2003 through the end of FY 2009-2010, a total of 947 participants have been provided access to the HUBSCO online training site and 759 participants have been provided access to the HUBSCO live- production site.
- A total of 10 on-site and off-site HUBSCO training sessions were conducted by the HUB Office in FY 2009-2010.

STATUTORY REQUIREMENTS

Effective April 20, 1999, and as a result of <u>Executive Order No. 150</u>, the Office for Historically Underutilized Businesses (HUB Office) was established in the Office of the Secretary of the North Carolina Department of Administration. HUB participation goals and reporting requirements for state agencies and public entities are contained in North Carolina Statute (NCGS) <u>143-48</u> for goods and services and NCGS <u>143-128.2</u>, <u>143-128.3</u> and <u>143-131</u> for construction projects. Further discussion of these statutes is mentioned below.

The report for FY 2009-2010 includes purchasing (goods and services) and construction projects data submitted to the HUB Office by state agencies and other public entities.

A. <u>PURCHASING (GOODS and SERVICES)</u>

The HUB Office serves as an advocate for HUB vendors, which includes businesses owned by minorities, women, persons with disabilities, disabled businesses, and non-profit work centers for the blind and severely disabled. The HUB Office promotes the State's on-line vendor registration and HUB certification process, provides technical assistance, and conducts training on how to conduct business with state government. The HUB Office captures data reflecting the State's HUB utilization and expenditures of the state agencies, community colleges, public schools and universities, while also serving as a resource to these agencies.

Executive Order No. 150 states North Carolina's Historically Underutilized Business participation goal to be that at least 10%, by dollar amount, of the State's total purchases of goods and services, to be derived from HUB vendors. Executive Order No. 150 further requires the submission of quarterly HUB purchasing reports to the HUB Office. *The goal for fiscal year 2009-2010 (July 1, 2009 through June 30, 2010) remains at 10%.*

The following legislation also addresses the State's minority business goals and reporting requirements for goods and services:

G.S. 143-48 (b) states "in part".... "Every governmental entity required by statute to use the services of the Department of Administration in the purchase of goods and services, every local school administrative unit, and every private, non-profit corporation other than an institution of higher education or a hospital that receives an appropriation of five hundred thousand dollars (\$500,000) or more during a fiscal year from the General Assembly shall report."

Cabinet Agencies, Council Agencies, Supporting Agencies, Community Colleges, Public School Districts and State Universities submit a quarterly HUB purchasing report to the Office for Historically Underutilized Businesses.

The figures reported include multi-year contracts. Because those figures are only reported in the year that the contract is actually awarded, HUB participation numbers may be reduced in

subsequent fiscal years. Total purchases and HUB participation are subject to change or differ from the submitted quarterly purchasing report data due to the "run date" of each report.

Agencies reporting through NCAS (North Carolina Accounting System) provide a snap shot of its purchases quarterly. The HUB Office compiles the reported purchase transaction amounts and generates a cumulative report. The adjustments made to the purchase orders are not recorded in the subsequent periods.

Purchasing and HUB Participation Quarterly Report data include purchase orders, and service contracts awarded each quarter.

Reports from the state reporting entities are due no later than thirty (30) days after the end of each quarter and reflect each entity's HUB purchases within the following categories:

- •Term Contracts
- •Commodity Purchases (Non-term contract)
- Service Contracts

B. <u>CONSTRUCTION PROJECTS</u>

Construction project data is an important component of the overall HUB participation reporting requirements. On December 6, 2001, the General Assembly enacted Senate Bill 914, which made historic changes to laws governing public construction in the State of North Carolina.

Senate Bill 914 was signed by Governor Michael F. Easley on December 19, 2001, and became effective January 1, 2002. Senate Bill 914 affords flexibility in the public construction bidding process, provides for significant new requirements for promoting the use of minority contractors, as well as documenting and reporting good faith efforts to that end. All public entities, including but not limited to, state agencies, universities, community colleges, public schools, county governments, municipalities and other local governments, are required to report both formal (=>\$500,000) and informal (<\$500,000) construction project data. Note: Effective August 23, 2007, for projects funded on or after July 1, 2007, the formal project threshold increased from \$300,000 to \$500,000.

The following legislation addresses the State's minority business goals and reporting requirements for construction:

G.S. 143-128.2 states "in part".... "The State shall have a verifiable ten percent (10%) goal for participation by minority businesses in the total value of work for each State building project, including building projects done by a private entity on a facility to be leased or purchased by the State."

G.S. 143-128.3 states "in part ".... "All public entities subject to G. S. 143-128.2 shall report to the Department of Administration, Office of Historically Underutilized Businesses, the following with respect to each building project: (1) The verifiable percentage goal. (2) The type and total dollar

value of the project, minority business utilization by minority business category, trade, total dollar value of: Contracts awarded to each minority group for each project, the applicable good faith effort guidelines or rules used to recruit minority business participation, and good faith documentation accepted by the public entity from the successful bidder. (3) The utilization of minority businesses under the various construction methods under G. S. 143-128 (a1).

G.S. 143-131 states "in part"..." (b) All public entities shall solicit minority participation in contracts for the erection, construction, alteration or repair of any building awarded pursuant to this section. The public entity shall maintain a record of contractors solicited and shall document efforts to recruit minority business participation in those contracts.

Construction data is captured electronically through the **HUBSCO Construction Reporting System,** a web-based reporting application. All public entities are required to report completed construction project data and submit it to the HUB Office. The HUBSCO system has the capability to allow each entity to generate and view its own report (<u>http://www.hubsco.com/</u>).

The report includes both total construction project value and HUB participation for construction projects. The design-related and miscellaneous values are captured by the HUBSCO system but not reported as a part of HUB participation (not required by G.S.143-128).

The HUB Office offers training to public entities on how to access and utilize the HUBSCO Construction Reporting System. The training schedule, training request forms, and system access forms are available via the HUB Office website (<u>http://www.doa.state.nc.us/hub/reports-hubsco.htm</u>).
