Sealed proposals will be received by the <u>North Carolina Department of Public Safety / North Carolina National</u> <u>Guard</u> in <u>Raleigh</u> NC, in the office of <u>North Carolina National Guard</u>, <u>1636 Gold Star Drive</u>, <u>Raleigh</u>, <u>NC 27607 in</u> <u>the Joint Force Headquarters Cafeteria</u> to <u>3:00</u> pm <u>August 2</u>, 20<u>18</u> and immediately thereafter publicly opened and read for the furnishing of labor, material and equipment entering into the construction of

This project consists of the renovation and additions to the existing National Guard Readiness Center in Jacksonville, NC (14,136 SF). This project includes more functional office space, additional storage, additional classroom space, a physical fitness room, accessibility improvements, energy efficiency upgrades, a new roof, and updated finishes. The existing building is structurally sound and currently in use. The building is primarily masonry load bearing construction with partial steel frame for the elevated roof area over the drill hall. The majority of non-load bearing interior partitions will be demolished, while load bearing partitions will remain; openings to be revised with added structural support. The additions will be added to the west, where they would be least invasive to existing and proposed site access and parking. The project includes all other work as shown, indicated or reasonably implied on the drawings and/or specifications for a complete, first class job.

Bids will be received for Single Prime. All proposals shall be lump sum.

## **Pre-Bid Meeting**

An Open pre-bid meeting will be held for all interested bidders on <u>July 17, 2018 --- 1:30pm ---- Jacksonville</u> <u>Readiness Center Building Renovation Project Site, 142 Broadhurts Road, Jacksonville, NC 28540.</u> The meeting will address project specific questions, issues, bidding procedures and bid forms.

The meeting is also to identify preferred brand alternates and their performance standards that the owner will consider for approval on this project.

In accordance with General Statute GS 133-3, Specifications may list one or more preferred brands as an alternate to the base bid in limited circumstances. Specifications containing a preferred brand alternate under this section must identify the performance standards that support the preference. Performance standards for the preference must be approved in advance by the owner in an open meeting. Any alternate approved by the owner shall be approved only where (i) the preferred alternate will provide cost savings, maintain or improve the functioning of any process or system affected by the preferred item or items, or both, and (ii) a justification identifying these criteria is made available in writing to the public.

In accordance with GS133-3 and SCO procedures the following preferred brand items are being considered as Alternates by the owner for this project:

**NOTE**: The bidder shall include <u>with the bid proposal</u> the form *Identification of Minority Business Participation* identifying the minority business participation it will use on the project <u>and</u> shall include either *Affidavit A* or *Affidavit B* as applicable. Forms and instructions are included within the Proposal Form in the bid documents. Failure to complete these forms is grounds for rejection of the bid. (GS143-128.2c Effective 1/1/2002.)

All contractors are hereby notified that they must have proper license as required under the state laws governing their respective trades.

General contractors are notified that Chapter 87, Article 1, General Statutes of North Carolina, will be observed in receiving and awarding general contracts. General contractors submitting bids on this project must have license classification for <u>"Unlimited Building" or "Unclassified"</u>.

<u>NOTE</u>--SINGLE PRIME CONTRACTS: Under GS 87-1, a contractor that superintends or manages construction of any building, highway, public utility, grading, structure or improvement shall be deemed a "general contractor" and shall be so licensed. Therefore a single prime project that involves other trades will require the single prime contractor to hold a proper General Contractors license. <u>EXCEPT</u>: On public buildings being bid <u>single prime</u>, where the total value of the general construction does not exceed 25% of the total construction value, contractors under GS87- Arts 2 and 4 (Plumbing, Mechanical & Electrical) may bid and contract directly with the Owner as the SINGLE PRIME CONTRACTOR and may subcontract to other properly licensed trades. <u>GS87-1.1- Rules .0210</u>

Each proposal shall be accompanied by a cash deposit or a certified check drawn on some bank or trust company, insured by the Federal Deposit Insurance Corporation, of an amount equal to not less than five percent (5%) of the proposal, or in lieu thereof a bidder may offer a bid bond of five percent (5%) of the bid executed by a surety company licensed under the laws of North Carolina to execute the contract in accordance with the bid bond. Said deposit shall be retained by the owner as liquidated damages in event of failure of the successful bidder to execute the contract within ten days after the award or to give satisfactory surety as required by law.

A performance bond and a payment bond will be required for one hundred percent (100%) of the contract price.

Payment will be made based on ninety-five percent (95%) of monthly estimates and final payment made upon completion and acceptance of work.

#### SPECIAL REQUIREMENT FOR BID SUBMISSION:

You may submit your bid package in advance of the opening date. Your sealed envelope will be held and unsealed at the bid opening time. If you wish to send your bid via US Mail, FedEx or UPS, please allow several days for delivery since the bid must be received (NOT postmarked) by the date and time stated in the solicitation.

Project Name must be clearly marked on the outside of the sealed envelope

You are not required to attend the bid opening, but if you plan to attend the public bid opening located at Joint Force Headquarters Cafeteria, 1636 Gold Star Drive, Raleigh, NC 27607, plan to arrive at least 30 minutes in advance of the bid opening to allow time to process through the security gate, park and then gain access to the building.

This notice along with picture identification is required to enter the security gate. Notify the guard at the gate that you are here for the <u>JACKSONVILLE READINESS CENTER BUILDING RENOVATION</u> bid opening with Project Manager William Burriola. On arrival in the lobby, check in with the front desk and then meet in the cafeteria.

Please note the gate guard nor the reception desk WILL NOT be allowed to accept packages of any kind.
