3.0 Response to Section 5.3.5 – Specifications

Iron Mountain provides a detailed shredding report with a volume based method of measuring the shred weight in pounds. However, we do not have a sample detailed report to provide at this time and we do not share any customer data due to proprietary reasons.

Below, in *Figure 1*, we have provided a Sample Shred Usage Report from our online account management tool, IMConnect. This InControl Shred Usage Report provides a summary level information on container volume which is captured during each service with an InControl scanner. Iron Mountain can also provide a more detailed Shred Usage Report that includes volumes in pounds.
