#### 10. STATE CONSTRUCTION OFFICE REPORT

Mr. Shumsky, PE provided the following updates:

The 42nd Annual State Construction Conference will be held on Thursday, March 2, 2023, at the NCSU McKimmon Center and will be a hybrid conference (in person with a virtual option).

During January 2023, the Design Review Section received 112 plans, provided 108 responses, and evaluated 32 Exemption Projects. Mr. Shumsky thanked NCDOA Leadership for supporting a reclassification of the State Construction Office Electrical Inspectors from Engineering Technician III to Engineer II. Mr. Shumsky stated, "As the Authority Having Jurisdiction, the State Construction Office Electrical Inspectors, Level III are responsible for enforcing the State Building Code and State Electrical and Fire Codes pertaining to electrical systems. Therefore, for building owner(s) to receive a construction permit and beneficial occupancy, the Electrical Inspectors are responsible for reviewing and approving electrical system plans prepared by other licensed professionals."

Mr. William Johnson, RA provided:

Preview of the State Construction Conference Break-Out Session: Cost Estimation and Current Bid Environment. Discussion topics included: Best Practices, Bid Package Performance Experience, and Escalation/Inflation Impacts on the Construction Industry.

Mr. Ali, PE provided the following updates:

The State Construction Office is the floodplain manager for State property. SCO currently enforces Executive Order ("EO") 123, much like NC communities enforce their own local floodplain ordinances. Proper enforcement ensures NC's continued participation in the NFIP. Governor Cooper signed Executive Order 226 in July 2022, which asks SCO, in conjunction with NCDEQ, NCDOT, NCEM, and NCORR (the "Team"), to update EO123. The updated policy shall minimize flood damage to state-owned assets, consider the impacts of sea level rise and climate change, analyze the effect of expanding the policy beyond State-owned construction to also include State-funded construction, and support natural hydrologic conditions and the beneficial services provided by the natural infrastructure. The update shall be developed with public stakeholder input. As such, SCO and NCEM will present the requirements of, and likely approaches towards compliance with, EO266 at the upcoming 2023 State Construction Conference. The session topic will present a brief history of EO123, why EO266 was introduced, how the "Team" will manage the task and potential policy changes that will affect State-owned construction and potentially State-funded construction projects.
